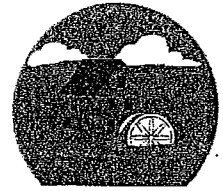

Please Note the Following:

- Criminal Record Checks will be run on all applicants.
- Upon approval each applicant must come to the Police Office and submit a picture I.D. which will be placed on their individual permit. Permits are to be carried at all times while soliciting in the Township.
- All applicants must strictly adhere to the Township's Ordinance and "No Solicitation List".
- The \$15.00 application fee for the Company must be submitted in cash or check at the time the application is submitted for review and approval.
- The Soliciting Fee will be payable in cash or check when the individual is approved and they pick up their individual soliciting permit.

In accordance with Peddling & Soliciting Ordinances for Middlesex Township: Licensees shall be prohibited from operating before 9:00 a.m. or after 9:00 p.m. on Monday through Sunday, prevailing time. This will be strictly enforced.
