**FEE: \$250.00-Road opening requiring excavation of roadway**

**\$75.00-Road opening Not requiring excavation of roadway**

**-Surface openings that are constructed parallel to the roadway. This fee is calculated based on the roadway openings that are constructed parallel to the roadway within the Township Right-of-Way and are more than 100 total linear feet in length.**

**i. Opening in pavement-\$100.00 base fee plus \$50.00 for every 100 feet of parallel**

**opening.**

**ii. Opening in shoulder-\$50.00 base fee plus \$25.00 for every 100 feet of parallel opening.**

**iii. Opening outside of pavement and shoulder-\$50.00 base fee plus \$25.00 for every 100 feet of parallel opening.**
